Candidates who have earlier applied for the vacancies notified vide Sl. No. 11 and 31 of the Notification referred as (1) above and Sl.No.6 of the Notification referred as (3) above and who are still eligible and willing to apply for the post on the basis of the changed reservation have to apply afresh (online), but they are exempted from registration fee and their age limit will be as prescribed in the earlier notifications, on submission of proof of earlier application. They may update their qualification and experience as per the existing UGC / AICTE Regulations as on the date of this notification for each post re-notified and shall furnish the earlier UTR Number in support of the claim of their earlier remittance of registration fee.

GENERAL INSTRUCTIONS

a. **Instruction Sheet I (General Instructions)** – can be downloaded from the website of the University – <http://faculty.cusat.ac.in> or www.cusat.ac.in.

b. **A working e-mail id of the candidate shall be given in the application:**

All communications in connection with the recruitment will be sent to the registered e-mail id only and hence the candidates are directed to check their e-mail periodically.

c. **Separate applications with prescribed fees, should be submitted for each post having separate serial number.**

d. **Qualifications and Experience:**

Information Sheet II containing details of qualifications prescribed for the posts can be downloaded from the website of the University, www.cusat.ac.in/faculty.cusat.ac.in.

e. **Age:** Age as on **01.01.2020** – Not more than 40 years for applying for the post of **Assistant Professors**. Age limit prescribed will be relaxed in the case of SC/ST and OBC (Non-Creamy Layer) candidates by 5 years and 3 years respectively. **Age limit prescribed will be relaxed in the case of Persons with Disabilities by 10 years (Maximum age for considering against State Government / State Government (Quasi) vacancies is limited to 50**

years).

f. Other conditions:

- i. The appointment against the above vacancies will be made as per UGC/ AICTE Regulations and Reservation Principles according to Cochin University of Science and Technology Act, 1986 and Kerala State Government Rules. The posts earmarked for Reserved Categories are exclusively reserved for them as per the provisions in the Kerala State & Subordinate Service Rules.
- ii. *A relaxation of 5% shall be allowed at the Bachelor's as well as the Master's Level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non-Creamy Layer) / Differently-abled for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading System is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on qualifying marks without including any grace mark procedure. A relaxation of 5% shall be provided (from 55% to 50% of the marks) to the Ph.D Degree holders who have obtained their Master's Degree prior to 19 September, 1991.*

g. Any corrigendum/addendum shall be posted only on the University website.

h. The applicants should possess the minimum qualifications as on the last date for receipt of applications. However, credentials, other than the minimum qualifications, obtained up to the date of Interview will be reckoned.

i. How to apply:

- j. Applications to the above posts have to be submitted online in the prescribed application form available in the University Website: www.cusat.ac.in/faculty.cusat.ac.in.
- k. Separate applications with prescribed fees, should be submitted for each post having separate serial number.
- l. Candidates who have passed their qualifying examination from Universities outside Kerala should forward the Eligibility Certificate obtained from this University along with their application.

Desirable:- Candidates who have passed the qualifying examination from Universities abroad can submit Equivalency Certificate issued by the Association of Indian

4. Candidates should apply online on or before **16.11.2020**.

One signed hard copy of the filled up online applications (Part A & Part B) along with Registration Fee and copies of documents to prove age, community, qualifications, percentage of marks, experience, copies / reprints of publication (if any) with proof of impact factor etc. should reach the Registrar, Cochin University of Science and Technology, Kochi – 682 022 before 5.00 PM on **23.11.2020**. Candidates who have applied online but failed to submit the hard copies of the application in time will not be considered for selection. Four hard copies of the filled up online applications and 4 copies/reprints of publications shall be produced at the time of certificate verification in connection with the interview.
